What is the consultation about?

The City of Montréal is seeking to amend the *Règlement autorisant la construction d'un complexe immobilier sur l'emplacement délimité par le boulevard René-Lévesque, l'avenue Atwater et les rues Tupper et du Sussex* (16-082) [by-law authorizing the construction of a building complex on the site bounded by René-Lévesque Boulevard, Atwater Avenue, and Tupper and du Sussex Streets]. The by-law, adopted by city council in 2017, aimed to provide a framework for the repurposing project for the site of the former Montréal Children's Hospital. The project included the construction of six towers, the renovation of the former nurses' residence, the construction of a community centre within the base of two of the six towers, as well as the transformation of two public squares.

The construction of the first five towers and the renovation of the former nurses' residence provided for in the initial project are underway. The transformation of Henri-Dunant and Hector-Toe-Blake squares is scheduled to begin in the fall of 2022, while the opening of the Peter-McGill community centre is planned for 2023.

The amendment to the by-law proposed by the City of Montréal aims to bring the maximum construction height for the site of tower six back from 61 metres to 12 metres.

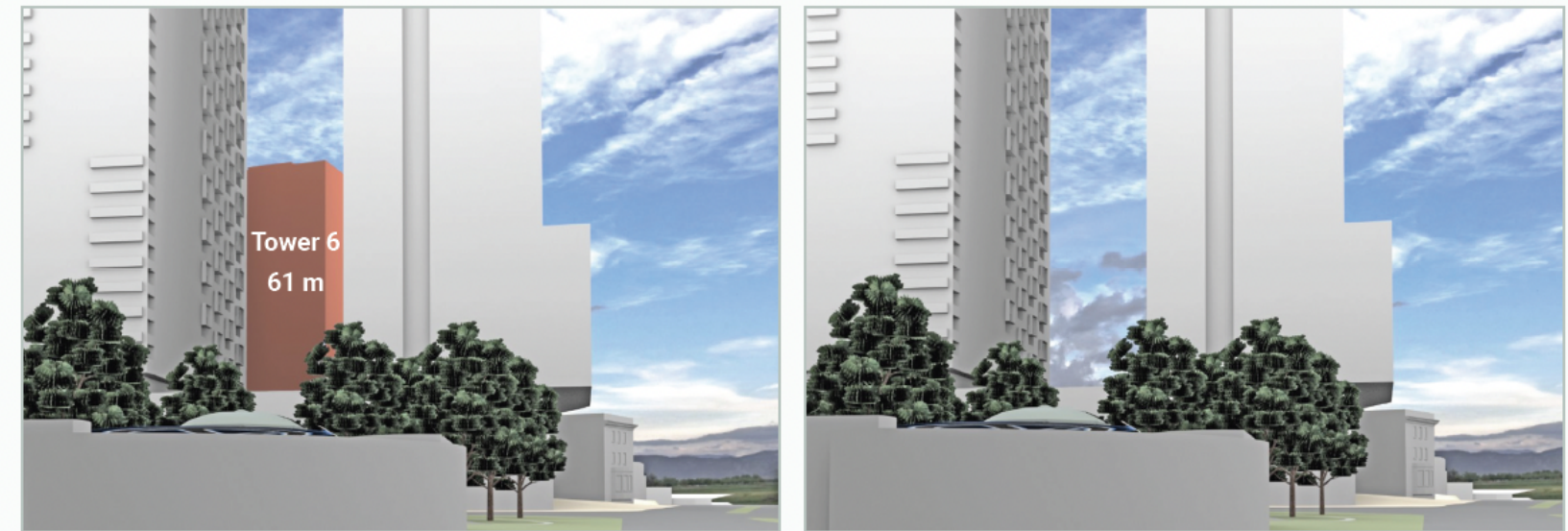
