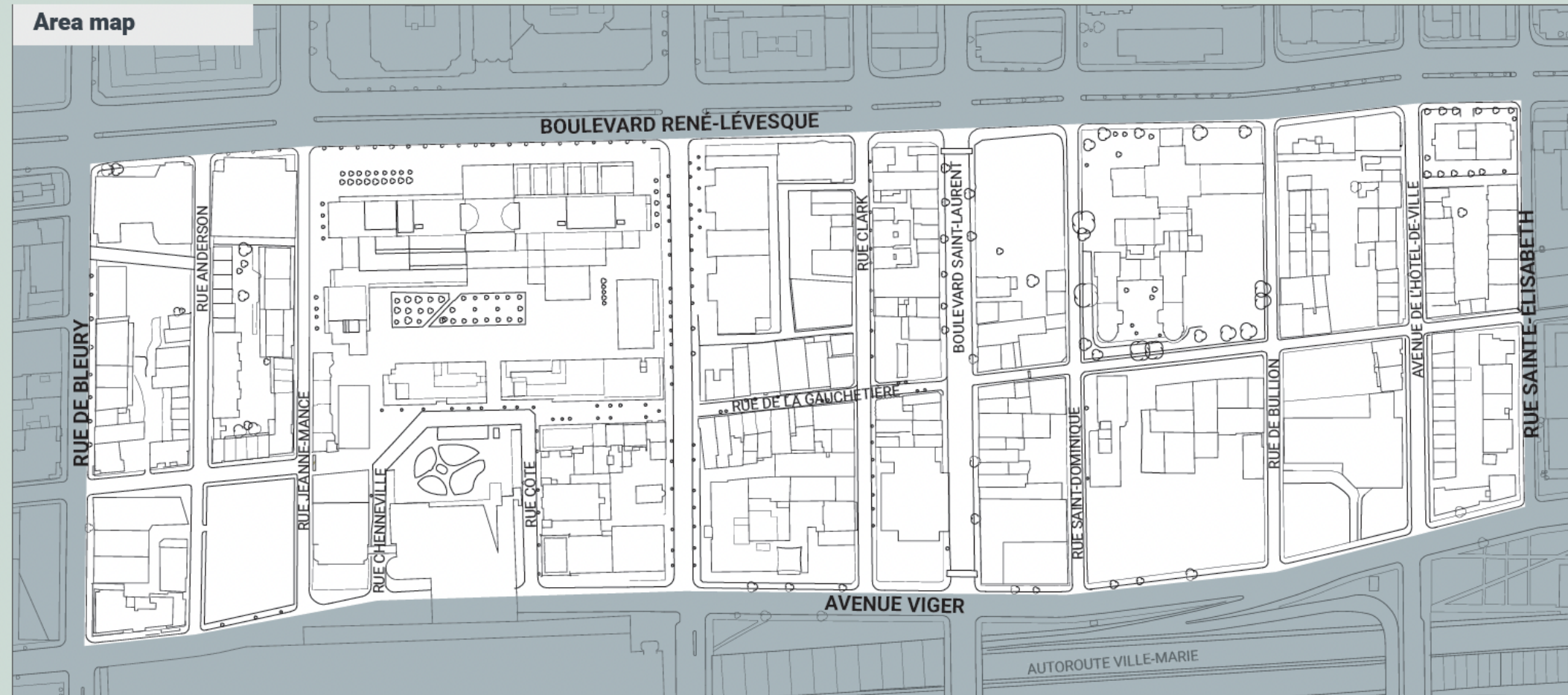
## What is the consultation about?

Montréal's Chinatown, located in the borough of Ville-Marie, is bounded by Saint-Elisabeth Street, De Bleury Street, Viger Avenue and René-Lévesque Boulevard.

There is considerable real-estate pressure in that area of the City. The Chinese community and heritage organizations have led the City of Montréal and the Québec ministère de la Culture et des Communications to form a Working Committee dealing with heritage protection in the neighbourhood.

## Give your opinion on:

- The proposed heights and densities
- The neighbourhood's heritage
- The commercial and economic vitality of the area in connection with the proposed modifications

It is proposed that the Master Plan be amended to identify most of the neighbourhood as a sector of exceptional value, and that height and density limits be lowered there. It is also proposed that an archeological potential study be required for all applications for permits or authorizations for work requiring excavations.
