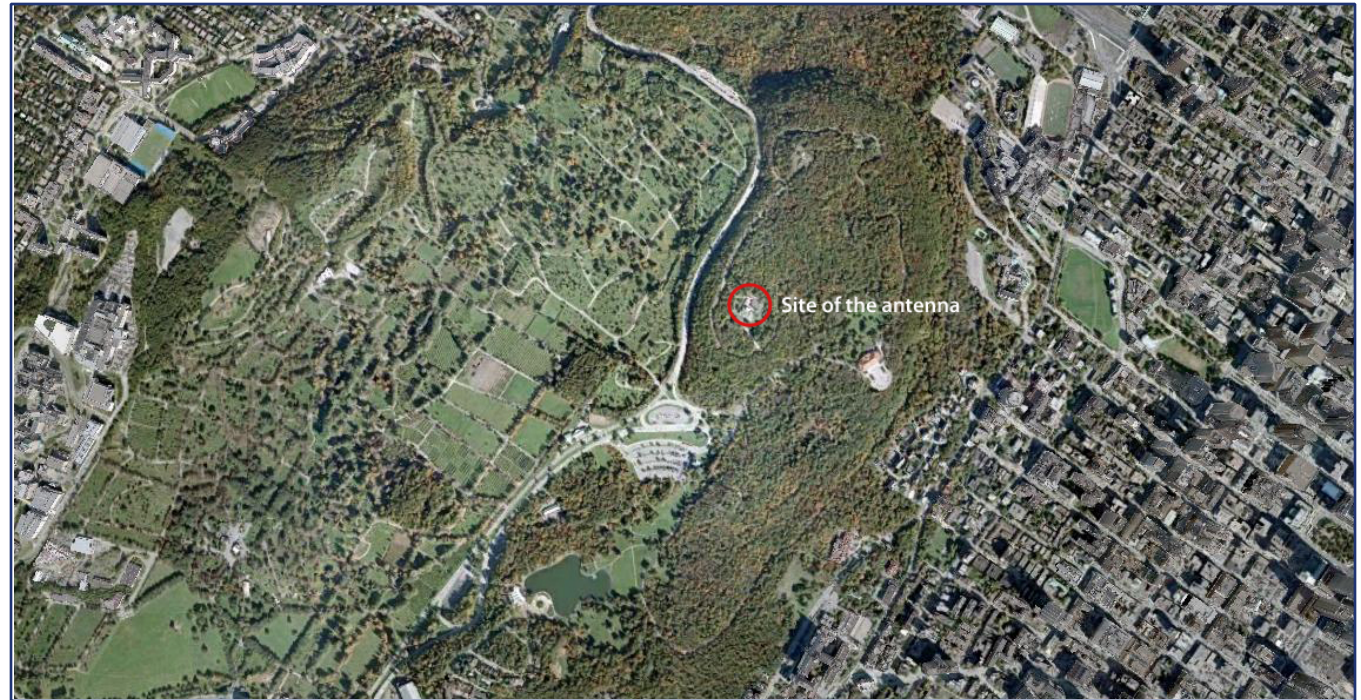

The City of Montreal must renegotiate the lease agreement for the site of The Canadian Broadcasting Corporation's (CBC) antenna in Parc du Mont-Royal, as the current agreement expires on December 31, 2008. The new draft agreement provides for the rental of the same site for a period of ten years, with an option to renew for an additional five years. The rent to be paid by The Canadian Broadcasting Corporation would amount to \$500,000 the first year, indexed annually to take into account increases in the Consumer Price Index. It is proposed that part of the amount be earmarked for the protection and enhancement of Mount Royal for the next ten years, or, if the renewal option is exercised, for the next 15 years.

CONTEXT

Two factors have justified the location of the CBC's antenna on Mount Royal: the latter's elevation; and its position at the centre of the Island of Montreal. In 1952, the first CBC television signals were broadcast from the site, following many decades where it was used for radio broadcasting. Today, the antenna serves most of the private FM stations, some private digital radio services, radiocommunications services, and all VHF and UHF television services for the greater Montréal area.
